While the Mediterranean has many legendary and fascinating islands, few match the intense beauty, history, cuisine, and culture of Mallorca, often called the jewel of the Balearics.

Under Spanish sovereignty, Mallorca has been an extraordinary witness to history, from the ancient world to the Moorish conquest to the Middle Ages and beyond. We will begin our morning at the superb Park Hyatt Mallorca, and our historian/guide will set the tone for the day with a short briefing on the island's story, unique features, and magical qualities.

From the Park Hyatt we will drive along the east coast of the island, past the bay of Alcudia to reach **Puerto Pollença**, a small town on the northern tip of Mallorca. From Puerto Pollença, we will embark on our sea voyage to discover the breathtaking peninsula of Formentor.

At this port, we will board a **llaüt**—a typical Balearic-style boat inspired by ancient Latin sailing vessels and originally built by Menorcan craftsmen ("mestres d'aixa") using techniques passed through generations. Once aboard, we will enjoy extraordinary views from the sea as we navigate along the spectacular coastline of Formentor before heading toward the **Formentor Royal Hideaway Hotel**, also known as "the hotel of the stars." There, we will enjoy a lunch of fresh, local Mediterranean specialties while overlooking the seafront.

This spectacular property belongs to the Barcelò Group and its origin dates back to the 1920s. Inspired by poetic odes extolling the beauty of the Formentor region and seeking to cultivate his own cultural oasis, **Adan Diehl**—an Argentinian avant-garde art and nature lover—purchased a large area of Formentor and moved there with his wife. By 1929, Diehl realized his vision of creating an artistic haven, and Hotel Formentor became a reality as writers, painters, and musicians visited from all over the world. Years later, the Boadas family took the baton from Diehl, vowing to preserve the hotel as a shelter for creative minds.

After lunch we will head back to the Park Hyatt along Mallorca's scenic snake road, which opens to a number of panoramic lookout and viewing points including **Mirador d'es Colomer**.
